XXVIII Conference of the Spanish Association of Professors of International Law and International Relations [1]

- In Granada, Spain, from 18 to 20 September 2019

On 25 November 2018, the European Council ratified the **Agreement on the Exit of the United Kingdom from the European Union**. However, in January 2019, the British Parliament rejected the ratification of this agreement by a resounding majority. Will the UK leave the EU unilaterally, will it do so with agreement, will it reverse its decision to withdraw? Regardless of this uncertain scenario, **the issue of Brexit and the withdrawal agreement affect the major challenges facing the European Union**.

These questions and approaches will be addressed from 18 to 20 September at the XVIII Conference of the Spanish Association of Professors of International Law and International Relations ([AEPDIRI](#) [2]), which will be held in the city of Granada under the title "**New world, new Europe. The redefinition of the European Union in the *Brexit* era**".

This conference, co-organised by AEPDIRI and the University of Granada, will be the occasion for the Euro-Arab Foundation to present the **different European projects** in which it is actively working. Detailed information on these projects can be found [here](#) [3].
